ITEM #2:	2018-19 BUDGET							
3:01	Council will continue discussions regarding the 2018-19 Town budget. All aspects of the budget may be discussed at this meeting.							
	Council continued their discussion of the 2018-19 budget.							
	Ultimately, it was determined that the following changes would be made to the draft budget, and that it will be considered for tentative approval on July 10.							
	 Public Works wages will be increased to add \$2/hr. to the wages of the Director Crew Chief, and to allow new hires to be paid up to \$17/hr. The appropriation allowing for preservation of historic buildings will be decreased by \$5,000, to \$55,000. The general fund's subsidies to water, sewer and trash will be cut by 50%, and the use of utility fund balance in those accounts will be increased. Water and sewer revenues will be increased to allow for rate adjustments. In General Fund Contingencies, the carryover of wildlands contingency revenues from FY18 (received or due and not spent) will be added, with an offsetting expenditure. The Manager will make minor adjustments to other line items as needed to balance the budget.
