By my signature below, I hereby certify that the information provided herein by me is true and complete to the best of my knowledge, and I agree to notify the Town immediately in writing if there are any changes in intended use of the water provided.

Due to an indeterminate and limited water supply, the Town does not provide water hookups beyond the Town's boundaries. Any requests for an out of town water hookup must be petitioned to and considered by the Mayor and Council to determine whether an exception to this policy would apply for 1) purposes of preservation of extant historical structures within areas historically supplied with out of town water and which require minimal water supply or 2) for some other purpose furthering the public health welfare and safety of the inhabitants of the Town of Jerome.

The Town reserves the right to reject any application for water service for reasons enumerated in Section 13-2-2 of the Town Code of the Town of Jerome, and to reconsider the provision of water service in the event of any change in use of the water provided.

As a condition of acquiring a hookup, you acknowledge and agree that the Town reserves the right to turn off water service for failure to pay all or any part of Town utility and/or trash collection charges.

EXCERPT: JEROME TOWN CODE Section 13-5

B. Water Hook Up Fees/Charges

Requests for water hookups shall be made by the property owner in writing to the Town Manager on forms provided by the Town. The following hookup fees shall be assessed:

1.	Residential	\$ 5,000.00
2.	Small Business	\$ 5,800.00
3.	Medium Business	\$ 6,200.00
4.	Large Business	\$ 7,000.00
5.	Small Industry	\$ 6,200.00
6.	Medium Industry	\$ 7,000.00
7.	Large Industry	\$11,000.00
8.	Vineyards, per parcel, as defined in Chapter 16 of the Jerome Town Code	\$ 7,000.00

Materials, equipment and labor involved in connection, including the cost of the water meter, will be charged in addition to the above listed hook up fees. Hook up fees may be paid no earlier than two years prior to issuance of a building permit. If a building permit is not issued before the two-year anniversary date of the payment, paid fees shall be refunded to the depositor and fees must be repaid at that time at the rates then in effect prior to issuance of a building permit.
