ORDINANCE NO. 362

AN ORDINANCE OF THE TOWN OF JEROME, ARIZONA, AMENDING SECTIONS I. AND V. OF ORDINANCE 361, ADOPTED OCTOBER 13, 2009, REGARDING TAX RATE INCREASES AND THE EFFECTIVE DATE THEREOF.

WHEREAS, the Jerome Town Council adopted Ordinance 361 on October 13, 2009; and

WHEREAS, said Ordinance, as adopted, inadvertently excluded tax rate increases for:

- Section 8A-415, Construction contracting: construction contractors;
- Section 8A-416, Construction contracting: speculative builders; and
- Section 8A-417, Construction contracting: owner-builders who are not speculative builders; and

WHEREAS, the Ordinance as adopted also included a typographical error regarding the numbering of Section 8A-410, Amusements, exhibitions and similar activities; and

WHEREAS, the Ordinance as adopted established an effective date for said tax rate increases of November 6, 2009, and it is necessary to change the effective date to January 1, 2010 in order to provide adequate notification of these tax rate increases; and

WHEREAS, the Jerome Town Council wishes to amend Ordinance 361 to include Sections 8A-415, 416 and 417, to correct the numbering for Section 8A-410, and to establish an effective date of January 1, 2010 for these increases;

NOW THEREFORE, BE IT ORDAINED by the Mayor and Common Council of the Town of Jerome, Arizona, as follows:

Section 1. Section 1 of Ordinance 361 is hereby amended as follows (additions underlined; deletions in ~~strikeout text~~):

Section I. Tax Rate Increase

The tax rate set forth in each of the following sections of the Town Tax Code is increased from three percent (3.0%) to three and one half percent (3.5%).

- Section 8A-405 Advertising
- Section 8A-415~~410~~ Amusements, exhibitions, and similar activities
- Section 8A-415 Construction contracting: construction contractors
- Section 8A-416 Construction contracting: speculative builders
- Section 8A-417 Construction contracting: owner-builders who are not speculative builders
- Section 8A-425 Job printing
- Section 8A-427 Manufactured buildings
- Section 8A-430 Timbering and other extraction
- Section 8A-435 Publishing and periodicals distribution
- Section 8A-444 Hotels
- Section 8A-445 Rental, leasing, and licensing for use of real property
- Section 8A-450 Rental, leasing, and licensing for use of tangible personal property
- Section 8A-455 Restaurants and bars
- Section 8A-460 Retail sales: measure of tax; burden of proof; exclusions
- Section 8A-470 Telecommunication services
- Section 8A-475 Transporting for hire
- Section 8A-480 Utility services

Ordinance No. 362 – Amending Ordinance No. 361

Section 2. Section V. of Ordinance 361 is hereby amended to provide that the Ordinance shall become effective on January 1, 2010.

Section 3. All other provisions of Ordinance 361, as adopted on October 13, 2009, are hereby ratified and confirmed.
