

TOWN ORDINANCE NO. 122

RELATING TO THE PARKING OF MOTOR AND OTHER VEHICLES, AND PLACING SIGNS FOR SALE OR TRADE ON SAME.

THE MAYOR AND COMMON COUNCIL OF JEROME DO ORDAIN AS FOLLOWS:

Section 1. In this ordinance the term "restricted parking" shall mean that parking at any time of the day or night is prohibited: "partially restricted parking" shall mean that parking will be permitted for not to exceed two hours between 7 a.m. and 1 a.m.; no parking between 1 a.m. and 7 a.m., no parking within ten feet of a street intersection. In partially restricted parking the vehicle shall be parked parallel with the curb and with a space of five feet between vehicles.

Section 2. It shall be unlawful to park a vehicle within ten feet of any fire hydrant.

Section 3. Parking on Main Street shall be as follows:

Restricted parking: From the intersection of Main Street and Jerome Avenue northerly to the intersection of Main and Clark Streets; From the intersection of Main Street and the County Road to a point opposite the northerly end of the DeZolt House; On the northerly side of Main Street from the Lyric Theatre building southeasterly to the County Road.

Partially Restricted Parking: on the northerly side of Main Street from Jerome Avenue to the Lyric Theatre Building; On the southerly side of Main Street parking will be permitted between 7 a.m. and 1 a.m. from Jerome Avenue to the Sullivan Apartments, and cars will be parked facing the curb.

Section 4. The following named streets and avenues are declared to be in the restricted parking district:

First Street ~~from its intersection with Jerome Avenue~~

That portion of Hull Avenue from its intersection with Jerome Avenue northerly to the town limits. Hull Avenue in front of the Jerome Hotel.

All other streets east of Hull Avenue and north of East Avenue.

Section 5. The following named streets and avenues are declared to be in the partially restricted district:

Clark Street.
School Street.
Center Avenue.
Verde Avenue.
The County Road.

Section 6. It shall be unlawful to park any vehicle on other parts of Hull Avenue and Jerome Avenue, at any time of the day or night, except that parking will be allowed on the easterly side of Hull Avenue from the north side of the Jerome Hotel to Jerome Avenue, and on the northerly side of Jerome Avenue, between the hours of seven o'clock a.m. and one o'clock a.m.

Section 7. Traffic on the County Road in the uptown district (direction) shall

take the right hand road at the intersection of the County road and Hull Avenue, that is, proceed northerly on Hull Avenue. South bound traffic on Hull Avenue is prohibited except traffic originating on Hull Avenue south of Conglomerate Street.

Section 8. Hereafter it shall be unlawful to park any automobile, auto truck or other vehicle on any street or avenue in the Town of Jerome with or without a sign or signs offering said vehicle for sale or trade.

Section 9. Hereafter it shall be unlawful for trucks or business cars to load or unload other than when parked parallel with the curb.

Section 10. Hereafter it shall be unlawful for any vehicle to turn around on Main Street, Hull Avenue or Jerome Avenue, other than at a street intersection.

Section 11. Hereafter it shall be unlawful for any auto or other vehicle to park on any street within the corporate limits of the Town of Jerome, without leaving nine feet clear street space for the passage of other vehicles.

Section 12. Hereafter it shall be unlawful for any auto, auto truck or other vehicle to park, stop or loiter for a period of more than five minutes on any part of Main Street, Hull or Jerome Avenues, when any portion of their vehicles is farther than sixteen feet from the curb.

Section 13. Hereafter it shall be unlawful for any vehicle to park on the left hand side of Main Street, Hull or Jerome Avenues, that is to say that a vehicle cannot park with the left hand side of the curb.

Section 14. Hereafter it shall be unlawful for any one to park a dead vehicle on any street or avenue within the corporate limits of the Town of Jerome, for a period of more than twenty-four hours.

Section 15. Any person violating the provisions of this ordinance shall upon conviction be fined in any sum of not less than \$5.00, nor more than \$200.00, or imprisonment in the Town Jail for not less than five days nor more than ninety days, or by both such fine and imprisonment.

Section 16. All ordinances or parts of ordinances in conflict with any of the terms of this ordinance are hereby repealed.

EMERGENCY CLAUSE: WHEREAS: as this ordinance is necessary and requires immediate operation to preserve the public safety of the inhabitants of the Town of Jerome, an emergency is hereby declared to exist, and this ordinance shall take effect from and after its passage, publication and posting, and the same is hereby exempted from the provisions of the referendum as provided by the constitution and laws of the State of Arizona.
