## ORDINANCE NO. 182

AN ORDINANCE LEVYING UPON THE ASSESSED VALUATION OF THE PROPERTY WITHIN THE TOWN OF JEROME, SUBJECT TO TAXATION A CERTAIN SUM UPON EACH ONE HUNDRED DOLLARS (\$100.00) OF VALUATION SUFFICIENT TO RAISE THE AMOUNT ESTIMATED TO BE REQUIRED IN THE ANNUAL BUDGET, LESS THE AMOUNT ESTIMATED TO BE RECEIVED FROM FINES, LICENSES AND OTHER SOURCES OF REVENUE: PROVIDING FUNDS FOR VARIOUS BOND REDEMPTIONS, FOR THE PURPOSE OF PAYING INTEREST UPON BONDED INDEBTEDNESS; PROVIDING A GENERAL FUND FOR GENERAL MUNICIPAL EXPENSES; AND THE PUBLIC WORKS RESERVE FUND, ALL FOR THE FISCAL YEAR ENDING THE 30TH DAY OF JUNE, 1980.

WHEREAS, by the provisions of the State law, the ordinance levying taxes for the fiscal year 1979-80 is required to be finally adopted not later than the third Monday in August, and

WHEREAS, the County of Yavapai, is now the assessing and collecting authority for the Town of Jerome, the Clerk is hereby directed to transmit a certified copy of this Ordinance to the Assessor and the Board of Supervisors of the County of Yavapai, Arizona,

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF JEROME as follows:

Section 1: There is hereby levied on each one hundred dollars (\$100.00) of the assessed value of all property, both real and personal, within the corporate limits of the Town of Jerome, except such property as may be by law exempt from taxation, a tax rate sufficient to raise the sum of \$9,483.00 for the purpose of providing a FUND OF THE TOWN OF JEROME for the fiscal year ending on the 30th day of June, 1980, but not to exceed \$2.37 per each \$100.00 assessed valuation of all real and personal property in the Town of Jerome subject to taxation.

Section 2: In addition to the tax rates set in Section 1, there is hereby levied upon each one hundred dollars (\$100.00) of assessed valuation of all property, both real and personal, within the corporate limits of the Town of Jerome except such property as may be by law exempt from taxation sufficient to raise the sum of \$1520, but not to exceed \$ .38 per each \$100.00 of the assessed value of all real and personal property in the Town of Jerome subject to taxation, such sum to be set aside and used for Public Works Reserve Fund.

Section 3: No failure by the County officials of the County of Yavapai, Arizona, to properly return the delinquent list and no irregularity in the assessment or omission in the same, or irregularity of any kind in any proceedings shall invalidate such proceedings or invalidate any title conveyed by any tax deed; nor shall any failure or neglect of any officer or officers to perform any of the duties assigned to him or to them on the day within the time specified work invalidation of any proceedings or of any such deed or sale or affect the validity of the assessment and


levy of taxes or of the judgment of sale by which the collection of the same may be enforced or in any manner affect the lien of the Town of Jerome upon such property for the delinquent taxes unpaid thereon, and no overcharge as to part of the taxes or of the taxes or of costs shall invalidate any proceedings for the collection of taxes or the foreclosure of the lien therefore or a sale of the property under such foreclosure; and all acts of officers de facto shall be valid as if performed by officers de jure.

Section 4: All ordinances and parts of ordinances in conflict herewith are hereby repealed.

Section 5: This ordinance shall be in full force and effect from and after its passage by the Council and approval by the Mayor.


