ORDINANCE NO. 192

AN ORDINANCE AMENDING THE BUSINESS LICENSE TAX OF THE TOWN OF JEROME, ARIZONA, BY REVISING THE RATE SCHEDULE ON SECTION 8-3-7 AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF JEROME, ARIZONA:

That Section 8-3-7 of the Code of the Town of Jerome, Arizona, is amended as follows:

Section 8-3-7 Business Licenses Fees

All businesses, occupations, professions, trades or callings listed hereunder shall pay a license tax as set forth in the following schedule annually, unless otherwise specified.

- A. Barbers; beauty operators; bicycle repair shops; bootblacks and shoe repair shops; coin operated games of skill; dress-maker shops; factories, fortune tellers or palmists; hotels; kiddie rides; machine shops; milliners; motels; motion picture theaters; music box operators; peddlers; photographers; tailors; taxi business; telegraph companies or agencies, for business done exclusively within the town not including any business to or from points without the state and not including any business done for the government of the United States, its officers or agents; telephone companies or agencies for business done exclusively within the town and not including any business done to or for the government of the United States, its officers or agents; and any business, occupation, trade or calling not specifically listed herein

\$ 50 per year

- B. Carnivals and/or circuses

\$100 per day

C. Retail Liquor Licenses

1. No. 6, All Types
2. No. 7, Beer & Wine
3. No. 8, Beer Only
4. No. 9, Off Sale, All Types
5. No. 10, Off Sale, Beer & Wine
6. No. 11, Off Sale, Beer Only
7. No. 16, Restaurant, Drink of Premises Only

\$ 50 per year

- D. Theaters, road shows and all other theatrical, athletic, artistic or musical performances, lectures, entertainment or exhibitions whether given in tent or open air; and any other temporary business not listed hereunder requiring a short-term license

\$ 5 per day

- E. Street artists producing original art on site


\$ 10 per month


