

ORDINANCE NO. 248  
 A ORDINANCE OF THE TOWN OF JEROME COMMON COUNCIL,  
 AMENDING ORDINANCE NO. 227, SECTION 3 101 A, B AND C  
 BY INCREASING SANITATION FEES

WHEREAS, the Town of Jerome Common Council is empowered to establish fees for services and other charges; and

WHEREAS, such fees and charges are an important revenue source to support the activities of the Town; and

WHEREAS, the Town Council has determined that an increase in fees for sanitation services is needed;

NOW, THEREFORE, BE IT HEREBY ORDAINED, by the Jerome Common Council that Section 3. Sanitation Fees/Charges is hereby amended as follows:

ORDINANCE NO. 249

AN ORDINANCE OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF JEROME, YAVAPAI COUNTY ARIZONA, ADOPTING "MARCH 1991 AMENDMENTS TO THE TOWN OF JEROME PERSONNEL POLICIES AND PROCEDURES MANUAL," AND "TOWN OF JEROME PAY PLAN," BY REFERENCE

BE IT ORDAINED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF JEROME, ARIZONA:

Section 1 - Adoption of the "March 1991 Amendments to the Town of Jerome Personnel Policies and Procedures Manual"

That certain document known as the "March 1991 Amendments to the Town of Jerome Personnel Policies and Procedures Manual," three copies of which are now on file in the office of the Town Clerk of the Town of Jerome, Arizona which were made a public record by Resolution No. 254, are hereby referred to, adopted and made a part hereof as if fully set out in this ordinance.

Section 2 - Adoption of the "Town of Jerome Pay Plan"

That certain document known as the "Town of Jerome Pay Plan," three copies of which are now on file in the office of the Town Clerk of the Town of Jerome, Arizona which were made a public record by Resolution No. 254, are hereby referred to, adopted and made a part hereof as if fully set out in this ordinance.

Section 3 - Repeal of Conflicting Ordinances

Any and all former ordinances or parts thereof conflicting or inconsistent with the provisions of this ordinance hereby adopted are hereby repealed.

Section 4 - Validity

If any section, subsection, sentence, clause, phrase or portion of this ordinance or any part of the "March 1991 Amendments to the Town of Jerome Personnel Policies and Procedures Manual" or the "Town of Jerome Pay Plan" adopted herein by reference, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.
