ORDINANCE NO. 252

AN ORDINANCE OF THE TOWN OF JEROME AMENDING THE ZONING MAP OF THE TOWN OF JEROME, ARIZONA SO AS TO CHANGE CERTAIN BOUNDARIES AND CLASSIFICATIONS.

BE IT ORDAINED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF JEROME, YAVAPAI COUNTY, ARIZONA AS FOLLOWS:

<u>Section 1</u> That certain parcel of land lying within the Town of Jerome, Arizona specifically described herein is hereby reclassified from C-1, General Commercial, to R1-5, Single-Family Residential:

The Hull Homestead Tract, Tract "B" and the H. W. Lewis Property, part of the Maine (USMS No. 1051), the No. 6 (USMS No. 1213) and the No 6 Fraction (USMS No. 3471) patented lode mining claims, Verde Mining District, Town of Jerome, Yavapai County, Arizona, more particularly described as follows:

Commencing at Corner No. 2 of the Hermit (USMS No. 590) patented lode mining claim and Corner No. 3 of said Main claim;
