ORDINANCE NO. 263

AN ORDINANCE OF THE TOWN OF JEROME, ARIZONA, AMENDING SECTION 106.B.
OF THE JEROME ZONING ORDINANCE ENTITLED DESIGN REVIEW BOARD
ESTABLISHMENT: COMPOSITION: TERMS OF MEMBERS: VACANCIES:
COMPENSATION OF MEMBERS, AND REPEALING ANY PREVIOUS INCONSISTENT ORDINANCES

WHEREAS, the Jerome Town Council has by motion approved an amendment to the Jerome Zoning Ordinance to allow a council member to serve on the Design Review Board as the council representative and as the Planning and Zoning Commission member;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF JEROME, ARIZONA:

Section 1: Section 106.B. of the Jerome Zoning Ordinance is hereby amended to read as follows:

B. ESTABLISHMENT: COMPOSITION: TERMS OF MEMBERS: VACANCIES: COMPENSATION OF MEMBERS

There is hereby established a Design Review Board of the Town of Jerome to be composed of seven (7) members. The membership shall consist of a Town Council member, who shall also serve on the Planning and Zoning Commission, and six (6) citizens of Jerome, who shall be persons qualified by design background, training, or experience, to be appointed by the Town Council. The Town Council member shall serve on the Board for as long as she serves on the Council, except as hereinafter provided. The six (6) public members shall serve for a term of three years. Members may, after a public hearing, be removed by the Council for inefficiency, neglect of duty, or malfeasance in office, in the event of which the Council shall file a written statement of the reasons for the removal. Three (3) unexcused absences during a term from any regular or special meeting may be grounds for termination at the will and pleasure of the appointing authority without the necessity of a hearing or notice and such action shall be final. In the event of a death, resignation, or removal from the Board, the vacancy shall be filled by the Council for the unexpired term. All members shall serve However, members of the Board may be reimbursed for actual expenses incurred in connection with their duties upon authorization or ratification by the Board and aproval of such expenditures by the Town Council.

Section 2: All previous ordinances inconsistent with these amendments are repealed by the adoption of these provisions.
