

ORDINANCE NO. 272
 AN ORDINANCE OF THE JEROME COMMON COUNCIL,
 AMENDING ORDINANCE NO. 259 SECTION 2, PARAGRAPH 101 BY
 INCREASING SEWER FEES; SECTION 2 PARAGRAPH 201 BY
 INCREASING SEWER CONNECTION FEES; AND SECTION 3 PARAGRAPH 101
 BY INCREASING SANITATION FEES

WHEREAS, the Town of Jerome Common Council is empowered to establish fees for services and other charges; and

WHEREAS, such fees and charges are an important revenue source to support the activities of the Town;

THEREFORE, BE IT HEREBY ORDAINED, by the Jerome Common Council as follows:

SECTION 2. SEWER FEES/CHARGES

101. Monthly Sewer Service Fee 75% of Water

201. New Service Fees/Charges

A. Schedule of Sewer Hook-Up Fees (for Sewer System Improvement Reserve):

<u>Classification</u>	<u>Unit of Usage</u>	<u>Hook-Up Fee</u>
(1) Single Residence	per Connection	\$1,000.00
(2) Multiple Residence	per Residence	1,000.00
(3) Bar Only	per Seat	100.00
(4) Hotel/Motel/B&B	per Room	500.00
(5) Manufacturing	per Connection	1,000.00
(6) Public Restroom	per Fixture	100.00
(7) Office	per 100 Sq. Ft.	25.00
(8) Restaurant	per Seat	100.00
(9) Retail Shop	per Shop	1,000.00

B. Any applicant not clearly in one of the above categories will negotiate fee with the Town Sewer Department. Applicants in more than one classification may be charged combined fees.

C. Fees for manufacturing which includes industrial water usage or liquid waste will be negotiated separately.

D. Applicants will also pay all costs of labor and materials for extending Town lines, the sewer tap itself and street repairs, as may be necessary by customer's requirements. This may be pro-rated where appropriate.

E. All receipts for sewer hook-up fees will be deposited into a Town "Sewer System Improvement Reserve" account and restricted to capital improvements projects for the sewer.


