

ORDINANCE 284

AN ORDINANCE OF THE JEROME COMMON COUNCIL
AMENDING ORDINANCE 272, ORDINANCE 278 AND ORDINANCE 281
CHANGING WATER, AND SEWER FEES

WHEREAS, the Town of Jerome Common Council is empowered to establish fees for services and other charges; and

WHEREAS, such fees and charges are an important revenue source to support the activities of the Town;

THEREFORE, BE IT HEREBY ORDAINED, by the Jerome Common Council as follows:

SECTION 1: CHANGING WATER RATES AND FEES

In addition to the foregoing charges, the prospective user of Town water system must pay for the cost of all materials, equipment and labor necessary for installation.

 - b. Disconnect/Reconnect \$50.00

2. Delinquency Charges
(applies to water, sewer and sanitation)
 - a. Returned Check \$ 2.25
 - b. Delinquent Payment \$ 10.00
 - c. Disconnect \$100.00

SECTION 2: CHANGING SEWER RATES AND FEES

A. MONTHLY SEWER SERVICE RATES 106% OF WATER

B. NEW SEWER SERVICE FEES/CHARGES

1. Capital Improvements Reserve
 - a. Single Residence - per connection \$2500.00
 - b. Multiple Residence - per residence \$2500.00
 - c. Bar Only - per seat \$ 250.00
 - d. Hotel/Motel/B&B \$1250.00
 - e. Manufacturing - per connection \$2500.00
 - f. Public Restroom - per fixture \$ 250.00
 - g. Office - per 100 sq. ft. \$ 62.50
 - h. Restaurant - per seat \$ 250.00



- C. Any applicant not clearly in one of the above categories will negotiate fee with the Town Sewer Department. Applicants in more than one classification shall be charged combined fees.
- D. Fees for manufacturing which includes industrial water usage or liquid waste will be negotiated separately.
- E. Applicants will also pay all costs of labor and materials extending Town lines, the sewer tap itself and street repairs, may be necessary by customer's requirements. This may be pro-rata where appropriate.
- F. All receipts for sewer hook-up fees will be deposited into a Town "Sewer System Improvement Reserve" account and restricted capital improvements projects for the sewer.

 - 1. Establishing New Account -0-
 - 2. Service Inspection/Turn-On \$10.00
 - 3. Credit Deposit -0-
- H. Miscellaneous Sewer Fees and Charges
 - 1. Customer Maintenance Support
 - a. Turn-off/Turn-on -0-
 - b. Disconnect/Reconnect: Actual Expense of the Town

Sections 13-5-3, 13-5-4, and 13-6-2 of the Town Code of Jerome, regarding notices and treatment of delinquent accounts, disconnect, appeal and liens and remedies, remain as stated in Ordinance 278.
