

ORDINANCE #299

AN ORDINANCE OF THE JEROME COMMON COUNCIL  
AMENDING ORDINANCE #295 (sanitation rates)

CHANGING SANITATION FEES & AMENDMENT TO SECTION 9-2-2  
OF THE JEROME TOWN CODE REGARDING LOCATIONS FOR PICK-UP.

WHEREAS, the Town of Jerome Common Council is empowered to establish fees for services and other charges; and

WHEREAS, such fees and charges are an important revenue source to support the activities of Town;

THEREFORE, BE IT HEREBY ORDAINED, by the Jerome Common Council as follows:

SECTION 1: Changing Sanitation Rates and Fees;

Section 2. Ordinance #299 is an amendment to section 9-2-2 of the Jerome Town Code regarding locations for pick-up. Any sanitation customers on a road too narrow or too steep for the garbage truck are responsible for getting their containers to a suitable road.
