ORDINANCE #314

**AN ORDINANCE OF THE JEROME COMMON COUNCIL AMENDING
ORDINANCE #299, RAISING SANITATION FEES 10%, AND
DELETING ALL COMPOSTING REFERENCES.**

**WHEREAS, the Town of Jerome Common Council is empowered to
establish fees for services and other charges; and**

**WHEREAS, such fees and charges are an important revenue source
to support the activities of Town;**

**WHEREAS, under the current budget sanitation fees are not
covering the cost of the service;**

**THEREFORE, BE IT HEREBY ORDAINED, by the Jerome Town
Council as follows:**

SECTION 1: NEW SANITATION RATES AND FEES
