ORDINANCE #349

AN ORDINANCE OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF JEROME, ARIZONA, REPEALING ORDINANCES NOS 234 AND 269 AAND "THE TOWN OF JEROME PERSONNEL CODE" AND ADOPTING THE TOWN OF JEROME PERSONNEL POLICIES, DATED DECEMBER 11,2007" BY REFERENCE; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; AND PROVIDING FOR SEVERABILITY

WHEREAS, that certain document known as the "The Town of Jerome Personnel Code" also known as "The Town of Jerome Personnel Policies and Procedures" is hereby repealed; and

WHEREAS, Ordinance No. 269 amended The Town of Jerome Personnel Policies and Procedures to require all Department Heads to live in the Town of Jerome; and

WHEREAS, the voters affirmed Ordinance No. 269 by referendum election on March 12th; and

WHEREAS, the residence requirement set forth in Ordinance No. 269 and affirmed by the voters is retained and reinstated in Section 7 Conditions of Employment, Paragraph C Residence Requirement of the "Town of Jerome Personnel Policies, dated December 11, 2007";

NOW THEREFORE, BE IT ORDAINED by the Mayor and Common Council of the Town of Jerome, Arizona, as follows:

Section I. In General.

- 1. That certain document known as "The Town of Jerome Personnel Policies, dated December 11, 2007", three copies of which are on file with the Town Clerk for the Town of Jerome, is hereby declared to be a public record; and**
- 2. That certain public record entitled "The Town of Jerome Personnel Policies, dated December 11,2007" is hereby adopted as the personnel policies of the Town of Jerome, Arizona, effective 30 days after the date of this ordinance.**

Section II Providing for Repeal of Conflicting Ordinances.

All ordinances and parts of ordinances in conflict with the provisions of this Ordinance or any part of the Code adopted herein by reference, are hereby repealed.

Section III. Providing for Severability.

If any section, subsection, sentence, clause, phrase or portion of this Ordinance or any part of the Code adopted herein by reference, is for any reason held to be invalid or unconstitutional by the

decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

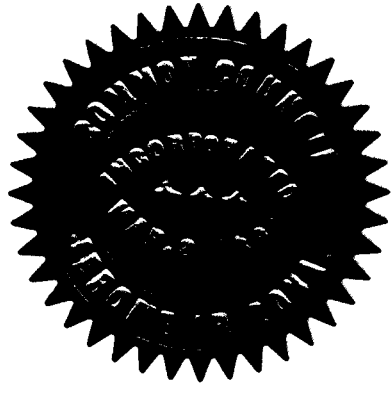
