### ORDINANCE #351

**AN ORDINANCE OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF JEROME, ARIZONA, AMENDING THE CODE OF JEROME, ARIZONA, CHAPTER 2 MAYOR AND COUNCIL, ARTICLE 2-1 COUNCIL, BY AMENDING SECTION 2-1-5 COMPENSATION RELATED TO AUTHORIZING COUNCIL TO ESTABLISH SALARIES FOR THE MAYOR AND COUNCIL MEMBERS BY RESOLUTION; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; AND PROVIDING FOR SEVERABILITY**

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Common Council of the Town of Jerome, Arizona, as follows:

#### **Section I. In General.**

The Code of Jerome, Arizona, Chapter 2 Mayor and Council, Article 2-1 Council is hereby amended by amending Section 2-1-5 Compensation to read as follows (deletions in strikeout; additions in ALL CAPS):

**MEMBERS OF THE TOWN SHALL BE FIXED FROM TIME TO TIME BY RESOLUTION OF THE COUNCIL.**
