ORDINANCE NO. #354

AN ORDINANCE OF THE COMMON COUNCIL OF THE TOWN OF JEROME, ARIZONA, RELATING TO THE PRIVILEGE LICENSE TAX; DECLARING THE DOCUMENT ENTITLED "2008 AMENDMENTS TO THE TAX CODE OF THE TOWN OF JEROME" A PUBLIC RECORD; AND ADOPTING BY REFERENCE THE "2008 AMENDMENTS TO THE TAX CODE OF THE TOWN OF JEROME" AS AMENDMENTS TO THE CODE OF JEROME, ARIZONA, CHAPTER 8 BUSINESS, ARTICLE 8-2 TRANSACTION PRIVILEGE TAX; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; PROVIDING PENALTIES FOR VIOLATIONS; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City desires to update the Model City Tax Code as required by the Model City Tax Code Commission;

NOW THEREFORE, BE IT ORDAINED by the Common Council of the Town of Jerome, Arizona, as follows:

Section I. In General.

That certain document known as "The 2008 Amendments to the Tax Code of the Town of Jerome," three copies of which are on file in the office of the Town Clerk of the Town of Jerome, Arizona, is hereby declared to be a public record.

The Code of Jerome, Arizona shall be amended by adopting "The 2008 Amendments to the Tax Code of the Town of Jerome" and that public record is hereby referred to, adopted and made a part hereof as if fully set forth in this ordinance.

Section II. Providing for Repeal of Conflicting Ordinances.

All ordinances and parts of ordinances in conflict with the provisions of this Ordinance or any part of the Code adopted herein by reference are hereby repealed.

Section III. Providing for Severability.

If any section, subsection, sentence, clause, phrase or portion of this Ordinance or any part of the Code adopted herein by reference, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

Section IV. Providing for Penalties.

Any person found guilty of violating any provision of this Ordinance shall be guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine not to exceed Two Thousand Five Hundred Dollars (\$2,500) or by imprisonment for a period not to exceed six (6) months, or both such fine and imprisonment. Each day that a violation continues shall be a separate offense punishable as herein described.

Section V. Providing for Effective Dates

The provisions of this ordinance and the public record adopted herein are effective from and after July 1, 2008.




