ORDINANCE OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF JEROME, ARIZONA, AMENDING THE CODE OF JEROME, ARIZONA, CHAPTER 2 MAYOR AND COUNCIL. ARTICLE 2-4 COUNCIL PROCEDURE, BY AMENDING SECTION 2 **4-7 COMMITTEES AND COMMISSIONS RELATED** TO PERMITTING A SITTING COUNCILMEMBER TO SERVE AS A MEMBER OF THE DESIGN REVIEW BOARD WITH A RESTRICTION AGAINST PARTICIPATION IN APPEALS: PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; AND PROVIDING FOR SEVERABILTY

NOW THERE FOR, BE IT ORDAINED by the Mayor and Common Council of the Town of Jerome, Arizona, as follows:

> Section I. In General.

The Code of Jerome, Arizona, Chapter 2 Mayor and Council, Article 2-4 Council Procedure, is hereby amended by amending Section 2-4-7 Committees and Commissions to read as follows (deletions in strikeout; additions in ALL CAPS):

> The Council may create such committees and commissions, standing or special as it deems necessary. They shall consist of as many members and shall perform such duties as the Council may require and shall exist at the pleasure of the Council. Persons elected to Town Council, upon being seated, shall no longer be qualified to serve on Town committees, including, but not limited to, Design Review, Planning and Zoning, Board of Adjustment, unless otherwise provided by law. FOR ANY APPEAL TO COUNCIL OF A DECISION OF ANY COMMITTEE, COMISSION OR BOARD, ANY COUNCIL MEMBER SERVING AS MEMBER OF SUCH COMMITTEE, COMMISSION, OR BOARD SHALL RECUSE HIMSELF AND NOT PARTICIPATE IN THE DISCUSSION, DELIBERATION OR DECISION AS TO THE APPEAL.

Section II. Providing for Repeal of Conflicting Ordinances.
