ORDINANCE NO. 412

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE TOWN OF JEROME, YAVAPAI COUNTY, ARIZONA, AMENDING SECTION 12-1-10, "OTHER RESTRICTED PARKING AREAS," OF THE JEROME TOWN CODE, REGARDING FREIGHT LOADING ZONES

WHEREAS, it is the desire of the Town Council to amend the Jerome Town Code with respect to the use of Freight Loading Zones;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF JEROME, YAVAPAI COUNTY, ARIZONA, AS FOLLOWS:

Section 1. Paragraph E of Section 12-1-10, "Other Restricted Parking Areas," is hereby amended as follows (deletions in ~~strikeout~~ text, additions in CAPITAL UNDERLINED text):

E. Freight Loading Zones. No person shall stop, stand or park a vehicle OR TRAILER for any purpose or length of time other than for expeditious unloading and delivery or pickup and loading in any place marked by signs and yellow painted curb as a freight curb loading zone. NO MOTOR VEHICLE OR TRAILER SHALL BE PARKED IN A FREIGHT CURB LOADING ZONE DURING THE HOURS INDICATED BY SUCH SIGNS UNLESS ATTENDED BY A QUALIFIED DRIVER, AND UNLESS IT IS ACTIVELY BEING LOADED OR UNLOADED. ~~during the hours indicated by such signs. In no case shall the stop for loading or unloading of materials exceed twenty (20) minutes.~~

~~Vehicles displaying State "Disabled Parking" identifying insignia may stand or park in a freight loading zone while loading or unloading persons for a period not to exceed five minutes.~~

Section 2. Following its adoption, this Ordinance shall be published by the Town Clerk in accordance with the requirements of A.R.S. § 39-203 *et seq.*

Section 3. All ordinances or parts of ordinances that are in conflict with the provisions of this Ordinance are hereby repealed to the extent of their inconsistency herewith.

Section 4. Should any section or provision of this Ordinance be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance, any provision incorporated by reference and any other provision of the Town Code as a whole or any part thereof other than the part so declared invalid.
